<p>Fee Due Dates:</p> <ul style="list-style-type: none"> Fees are payable in advance (“upfront”) for each month and must reflect in Kay-Dee’s bank account by the first (1st) of each month. On enrolment and/or the first (1st) day of attendance of your child, the fees due for the month in which your child starts must be paid in advance (upfront”), pro-rata if applicable, and thereafter in full on the first (1st) of each month following.
<p>FREE Extra-Mural Activities:</p> <ul style="list-style-type: none"> Are subject to change at the owner’s discretion (subject to terms & conditions).
<p>Additional Extra Mural Activities available (price available on application):</p> <ul style="list-style-type: none"> Baking / Computers / Swimming / Gymnastics
<p>Deposit (applicable to foreign parents only):</p> <ul style="list-style-type: none"> A once-off deposit equivalent to one (1) month’s fee may be applied at the discretion of Kay-Dee Educare Management, to be paid in advance (“upfront”). The deposit will be refunded in the last month of the required written notice period. The deposit may not be used in lieu of payment and will only be refunded once all payments due have been settled.
<p>Discount:</p> <ul style="list-style-type: none"> A discount will be given at the principal’s discretion on the fees of the second (2nd) child, and any subsequent children that the family has in the school at the same time.
<p>Development Levy:</p> <ul style="list-style-type: none"> We charge an R50 development levy billed quarterly for each child per family in the last month of each term, i.e. March, June, September and November. This levy is used for new infrastructure projects and replacement or refurbishment of existing infrastructure.
<p>Notice Period:</p> <ul style="list-style-type: none"> Twenty (20) business days’ written notice is required, and an additional two (2) months cancellation penalty charge may be applicable in the circumstances at Kay-Dee Educare’s discretion.
